Hello [REDACTED],

Hope you are doing fine. I am going to run this project for you :)

Below are the steps we need to take to launch the project:

1. A **list of key-words** for collecting tweets. We need a wide list of words related to the topics of interest to you - we will collect tweets containing these phrases. I've prepared a basic list. Could you supplement it with phrases that should be included in particular topics? I mean the words that you yourself use to find news and information on these topics (this is tab 1 in attachment "Step 1 - keywords")
2. A **list of topics and subtopics**. Once we have a collection of tweets based on the keywords (point 1), we need to classify them into appropriate topics and sub-topics. In order to increase the readability of the data, we suggest, in addition to the 5 proposed topics, to create sub-topics. Here, we need your support to classify it in such a way that is convenient for you. Please write down the sub-topics that should be included within each topic. **A short description of the topics and sub-topics would be also useful.** The better we understand the (sub)topics - the more precise and accurate classification we will be able to create (this is tab 2 "Step 2 – topics" – we prepared some examples, but you do not have to stick with it).

3. In the meantime, we are preparing our IT infrastructure to launch this project.
